



# **CONTEST RULES**

## **1. CONTEST PERIOD**

- 1.1 Contest entries are open from April 4, 2024, 12:00 a.m. Eastern Standard Time (EST) and will be accepted until June 30, 2024, 11:59 p.m. EST (hereinafter referred to as "**Contest Period**").
- 1.2 A random draw will take place on Friday, July 5, 2024, at 3:00 p.m. (EST) at the Kaleido Growth Inc. head office, located at 1035 Wilfrid-Pelletier Avenue, Suite 500, Quebec City, Quebec, G1W 0C5.

#### 2. How to participate

- 2.1 To obtain one (1) valid entry in the "Kaleido + Emma | Win \$1,000 RESP + \$500 worth of groceries" contest, participants must complete and submit the Kaleido form (hereinafter referred to as "Kaleido Form") or Emma form (hereinafter referred to as "Emma Form") during the **Contest Period.** These forms are accessible via one of the following pages:

- 2.2 As described in paragraph 2.1, there is a limit of one entry via the **Kaleido Form** and one entry via the **Emma** Form per person, for *a total of two* (2) *valid entries per person* for the entire **Contest Period**.
- 2.3 No purchase necessary.

#### **3.** CONDITIONS OF PARTICIPATION

- 3.1 The contest is open to Quebec residents aged 18 and over, and to New Brunswick residents aged 19 and over.
- 3.2 Employees, agents of Kaleido Growth Inc. and the Kaleido Foundation (hereinafter referred to as "**Kaleido**"), scholarship plan representatives and regional directors for Kaleido Growth Inc., members of the committee responsible for the random draw, as well as their immediate families (father and mother, brother and sister, children and spouse) and persons with whom they reside are not authorized to participate in this contest.
- 3.3 Employees, agents of Emma Financial Services Inc. and Emma's representatives and/or advisors, as well as their immediate families (father and mother, brother and sister, children and spouse) and persons with whom they reside are not authorized to participate in this contest.
- 3.4 Odds of winning the prize depend on the number of valid entries received during the **Contest Period**. Each entry made in accordance with paragraph 2.1 is equivalent to one valid entry, for a maximum of two (2) possible entries per person.

## 4. **DESCRIPTION OF PRIZES**

- 4.1 The **Prize** (hereinafter referred to as "**Prize**") consists of one (1) **deposit of one thousand dollars** (\$1,000) (hereinafter referred to as "**Amount**"), which will be paid, as applicable, as initial capital in connection with the opening of a new Kaleido IDEO+ **Registered Education Savings Plan** (hereinafter referred to as "**RESP**") or as an additional contribution to an existing IDEO+ **RESP** <u>AND</u> a **five hundred dollar** (\$500) gift card (hereinafter referred to as "Gift Card"). The winner can choose a **Gift Card** from the following grocery stores: **IGA**, **Metro, Super C or Maxi**.
- 4.2 Kaleido Growth Inc. and Emma Financial Services Inc. (hereinafter referred to as "Contributories") agree to contribute, in equal parts, to the Amount and the Gift Card that will be paid and/or awarded to the designated winner, as mentioned in paragraph 4.1. The \$1,500 value of the Prize is thus divided between the two Contributories, i.e., \$750 from each source.
- 4.3 The **amount** deposited in the **RESP** will be subject to the conditions set out in the current prospectus (see prospectus at <u>www.kaleido.ca/en/</u> for more information on applicable fees and, if applicable, rules based on the age of the designated beneficiary).

#### 5. How the Prize will be awarded

- 5.1 During the random draw, one (1) winner will be selected from all entries received from Quebec and New Brunswick residents during the **Contest Period**.
- 5.2 Kaleido Growth Inc. will contact the winner by telephone or email no later than fifteen (15) business days after the draw.
- 5.3 To be declared a winner, the participant must correctly answer a simple mathematical question. If the entrant selected as the winner does not correctly answer the mathematical skill-testing question or cannot be reached within fifteen (15) business days of the draw date, his or her entry will be cancelled and another entry will be drawn until all prizes have been awarded.

- 6.1 By entering this contest, the winner authorizes Kaleido Growth Inc., the Kaleido Foundation and Emma Financial Services Inc. to use his or her name and/or image, including photo and/or voice, and place of residence (city and province only) for publicity purposes related to this contest, without compensation.
- 6.2 Subject to paragraph 6.1, personal information such as mailing addresses, telephone numbers, email addresses and age is collected solely for the purpose of administering this contest and will not be used for any other purpose without consent. By providing this information, participants consent to its use for the purposes indicated on the registration form.

- 6.3 The winner will be required to sign a document attesting to his or her eligibility and compliance with these Contest Rules (hereinafter referred to as the "**Prize Form**") and return it as per the instructions received by email or telephone, within the time period clearly indicated on the document.
- 6.4 The winner must comply with the terms and conditions described in the current prospectus.

- 6.8 Refusal to accept the **Prize** releases Kaleido Growth Inc., the Kaleido Foundation and Emma Financial Services from any and all liability and obligation to the winner.
